
#### **Forward**

The Human Capital Index, a measure of a nation's productivity and income potential, is alarmingly on the decline. This deterioration is a direct consequence of the escalating global conflict. Instead of nurturing human potential and economic growth, countries are diverting vast resources towards military expenditure. Ukraine's allocation of 37% of its GDP to defense is a stark example of this trend.

Russia, the United States, and China, the world's largest military spenders, exacerbate the issue. Beyond these major players, over fifty countries currently grapple with internal or external conflicts. The situation is particularly dire in Africa, where nations like Nigeria, the DRC, and CAR are embroiled in turmoil, their human capital potential unrealized. The plight of Least Developed Countries, with minimal economic opportunities, is further compounded by these global challenges.

The specter of additional conflicts, such as the potential confrontation between Lebanon and Israel, with Turkey as a possible ally, casts a long shadow over the future. These developments threaten to further erode global human capital and hinder economic progress.

## **A Few Highlights for Export Businesses**

#### 1. Collateral-Free Loans:

A game-changer for MSMEs in the manufacturing sector is the introduction of a credit guarantee scheme offering term loans for machinery and equipment without requiring collateral or third-party guarantees.

## 2. Risk-Sharing Mechanism:

This scheme also establishes a self-financing guarantee fund that pools credit risks, providing coverage up to ₹100 crore per applicant. Borrowers pay minimal upfront and annual fees based on the reducing loan balance, making credit more affordable.

#### 3. Credit Guarantee for Stressed MSMEs

Recognizing the challenges faced by MSMEs during financial hardships, the budget proposes a new mechanism to ensure continued credit access for those categorized as "special mention accounts" (SMA) due to unforeseen circumstances. This government-backed guarantee will help businesses maintain operations and avoid transitioning into non-performing assets (NPAs).

#### 4. Increased Mudra Loan Limits

Entrepreneurs with a proven track record of successful loan repayments can now access larger funds for business expansion. The Mudra loan limit under the "Tarun" category has been increased from ₹10 lakh to ₹20 lakh.

#### 5. Enhanced SIDBI Presence

To provide direct credit support to MSMEs in key clusters, the Small Industries Development Bank of India (SIDBI) will establish 24 new branches this year, expanding its reach to 168 out of 242 major clusters within three years.

#### 6. Boosting Food Processing

Financial support will be provided for establishing 50 multi-product food irradiation units and 100 NABL-accredited food quality and safety testing labs. This initiative aims to enhance food safety standards and propel MSME units involved in food processing.

#### 7. E-Commerce Export Hubs

The government plans to create e-commerce export hubs in Public-Private-Partnership (PPP) mode. These hubs will offer trade and export-related services under one roof, making it easier for MSMEs and artisans to sell their products in international markets.

The Union Budget 2024 has also introduced several measures to boost India's economy, enhance manufacturing capabilities, and promote self-sufficiency. The highlights are:

## 1. Production-Linked Incentive (PLI) Scheme:

- · The PLI scheme is a major focus in the budget. It aims to encourage investment and generate employment.
- Sectors like large-scale electronics, IT hardware, automobiles, auto components, and pharmaceuticals have received significant allocations under the PLI scheme.
- vThe total PLI incentive is expected to increase substantially, potentially reaching Rs 14,167.1 crore in FY25.
- The government may expand the scheme to include more labor-intensive sectors such as textiles, leather, footwear, and toys.

#### 2. Customs Reforms:

- Adjusting customs duties can effectively reduce imports and stimulate domestic manufacturing.
- The budget aims to promote self-sufficiency, boost manufacturing capabilities, and attract investments in strategic sectors.
- Changes in customs tariffs are expected, which remained unchanged in the interim budget for 2024.

## From the Editor's Desk

## India's Gateway to Global Trade: The Rise of Vizhinjam Mothership Transshipment Port

For decades, India's dependence on foreign transshipment ports like Colombo, Singapore, and Dubai has hampered its maritime efficiency and added unnecessary costs to international trade.

Now, with the arrival of the first "mothership" at the Vizhinjam International Seaport in Kerala, India has taken a significant leap towards becoming a dominant player in global maritime trade. The term "mothership" refers to large cargo vessels that act as central hubs for transshipment. Smaller feeder ships bring cargo to the mothership, which then consolidates and transports it to its final destination.





Here we will explore:

- Location
- The significance of the Vizhinjam port,
- Its potential impact on the Indian economy

The Vizhinjam International Seaport is located in Vizhinjam, a coastal town in the Thiruvananthapuram district of Kerala, India.

- State: Kerala
- District: Thiruvananthapuram (also known as Trivandrum)
- Town: Vizhinjam

It's situated approximately:

- 16 kilometers south of Thiruvananthapuram city center.
- 14 kilometers from Thiruvananthapuram International Airport.
- 10 nautical miles from the International Maritime Route

## Stages of Operation:

- Partial Operations: The port began limited operations in October 2023.
- Trial Run: As of July 2024, the port is currently undergoing trial runs. This signifies testing the infrastructure, equipment, and overall operational procedures to ensure smooth functioning before full-scale operations begin.
- Full Operation (Phase 1): The first phase of Vizhinjam is expected to be fully operational by September 2024 (or potentially even a few months earlier).
   This phase will likely focus on handling containerized cargo for transshipment.
- Complete Project Completion: The entire Vizhinjam project is envisioned in multiple phases. While Phase 1 is nearing completion, subsequent phases aiming to expand capacity are expected to be finished by December 2028.

## Importance of Vizhinjam Port

Vizhinjam port holds immense importance for India's international trade due to several factors:

#### ➤ Reduced Costs and Increased Efficiency:

 Transshipment Hub: Currently, India relies on foreign ports like Colombo and Singapore for transshipment, adding extra costs and delays. Vizhinjam eliminates this dependence, allowing cargo to be directly loaded onto motherships, saving money and expediting movement.

## > Strategic Location:

- Global Shipping Routes: Situated near the southern tip of India, Vizhinjam is perfectly positioned on major East-West shipping routes connecting Europe, the Middle East, and Asia.
- Increased Capacity and Advanced Technology:
- Deepwater Berths: The port's deepwater berths can accommodate the largest container ships, allowing India to handle a significantly higher volume of cargo traffic.
- Modern Infrastructure: Advanced equipment and automation systems will facilitate faster turnaround times for ships, further enhancing overall efficiency.

## ➤ Delivery:

 Faster Delivery Times: Efficient cargo movement through Vizhinjam will lead to quicker delivery of goods for both import and export.

- Increased Trade Volume: The ability to handle larger vessels and higher cargo volumes will significantly boost India's overall international trade activity.
- ➤ Global Recognition: A successful Vizhinjam port will position India as a major player in global maritime trade, attracting more investment and international partnerships.

The Vizhinjam port enjoys a significant advantage due to its proximity to the main maritime route:



• Distance: The port is situated only 10 nautical miles (around 19 kilometers) away from the heavily trafficked east-west shipping channel connecting Europe, the Persian Gulf, Southeast Asia, and the Far East.

This close proximity translates to several benefits for India's imports and exports:

- Reduced Deviation: Ships traveling on the main route can easily reach Vizhinjam with minimal deviation, saving time and fuel compared to ports further inland.
- Attracting Business: The close proximity makes Vizhinjam a more attractive option for shipping lines, as it minimizes the additional distance and time needed for a port call.
- Faster Cargo Movement: Efficient access to the main route allows for quicker loading and unloading of cargo onto motherships, expediting the overall import and export process.
- Competitive Advantage: The convenient location positions Vizhinjam to compete effectively with established transshipment hubs that might be geographically further away from the main shipping routes.

# International Connectivity from Vizhinjam Port

This close proximity translates to several benefits for India's imports and exports:

#### > Sea Connectivity:

- Proximity to Main Shipping Route: Located just 10 nautical miles from the busy east-west shipping lane connecting Europe, the Middle East, Southeast Asia, and the Far East. This minimizes deviation for large vessels and makes Vizhinjam a convenient port of call.
- Deepwater Berths: The port's natural depth exceeding 20 meters allows it to accommodate the largest container ships (ultra-large container vessels with capacity exceeding 15,000 TEUs). This caters to the growing trend of larger vessels in global trade.

#### ➤ Land Connectivity:

- Hinterland Development: Plans are underway to develop a robust network of roads and railways connecting Vizhinjam to major industrial and commercial centers within India. This will ensure efficient movement of cargo to and from the port.
- Multi-Modal Logistics Hub: The project envisions developing a multi-modal logistics hub around the port, integrating road, rail, and sea transportation seamlessly. This will facilitate faster and more cost-effective cargo movement.

## ➤ Technological Connectivity:

Automation and IT Systems: The port is being equipped with advanced automation systems and IT infrastructure to streamline cargo handling, documentation, and customs clearance processes. This will expedite turnaround times for vessels and improve overall efficiency.

## ➤ Global Connectivity:

 Free Trade Zone and Warehousing: The Vizhinjam project includes plans for a Free Trade Zone and warehousing facilities. This will attract international businesses and create a hub for value-added activities like processing and packaging before cargo reaches its final destination.

## ➤ Air Connectivity:

Proximity to Airport: The port is situated around 14 kilometers from the Thiruvananthapuram International Airport. This facilitates easy movement of personnel and time-sensitive cargo shipments.



Vizhinjam's proximity to the main maritime route acts as a magnet for international shipping traffic, streamlining cargo movement and boosting India's trade efficiency.

Last but not the least, Vizhinjam will act as a game-changer for India's international trade. This allows India to compete more effectively in the global market and establishes the country as a key player in the global maritime trade network.



# Trade Knowledge - Export Promotion Incentive Schemes

The Indian Government aims to increase its gross domestic product (GDP) from its current \$3.9 trillion to \$5 trillion by 2025. To reach this goal, the country must increase its exports to \$1 trillion at the same time. One way to do this is through export incentives, which offer financial and non-financial incentives for exporters. This means that every export business needs to be aware of these incentives to succeed.



## **Export Incentive Schemes in India**

Export incentives are a foreign exchange management measure introduced in India by the Ministry of Commerce and Industry to facilitate the expansion of exports and also to help the export sector grow.

These incentives are offered to encourage commercial growth, boost exports, achieve self-sufficiency and ensure a higher reach of local products.

## How do export incentives work in India?

Export incentives in India are economic assistance given to exporters like low-cost loans, tax exemptions, subsidies and government-financed advertisements, among others, it helps them reduce the overall export cost, and thus helping them set competitive prices in the global market. All government incentives by countries must be in compliance with the World Trade Organization (WTO), which keeps a check on legal and ethical world trade practices.



## Top export incentives for exporters

Pre-Shipment Schemes and Post Shipment Schemes along with other schemes are available.

## ➤ Pre-Shipment Incentive Schemes

## 1. EPCG (Export Promotion Capital Goods Scheme)

Under this scheme, capital goods (goods that are used to manufacture other products like leather used to make leather bags, etc) used in the pre-production, production, and in post-production of final export products can be imported at 0% customs duty, also called Zero duty EPCG. This scheme also helps reduce the service exporter's capital costs.

#### 2. Interest Equalisation Scheme

The Government of India introduced the Interest Equalisation Scheme (IES) in April, 2015 to support Indian exporters with shipment credit. This is a rebate of interest provided on pre and post shipment export credit like packing credit. Banks provide this benefit to the eligible exporters and claim a reimbursement of same from RBI based on certification by an external auditor.

The scheme covered labor-intensive sectors that accelerated the potential for employment generation in the country. The key sectors covered under the scheme include coir and coir products, toys and sports items, readymade garments and fabrics, glass and glassware, handicrafts and handloom products, ceramic products and cosmetics, processed agricultural and food items and toiletries, among others.

## 3. AAS (Advance Authorization Scheme)

Advance Authorization Scheme (AAS) allows duty-free imports of raw materials, which are required to produce and manufacture final export products. The provision covers fuel, packaging material, and some wastage during the production of the final product. It allows exporters to import raw materials at 0% import duty if those raw materials will be used to manufacture export products.

## Post-Shipment Incentive Schemes

## 1. SEIS (Service Exports from India Scheme)

SEIS was introduced to encourage sellers who export notified services. Under this export scheme, an incentive of 3-7% of the net foreign exchange earnings is provided to service exporters. The requirement from an exporter is to have an active IEC with minimum net foreign exchange earnings worth US\$ 15,000 (INR 11L approx) to be eligible for a claim under the scheme.

#### 2. RoDTEP (Rebate of Duties & Taxes on Exported Products scheme)

Replacing the old MEIS (Merchandise Exports from India Scheme) in a phased manner from December 2020, the RoDTEP is the new export incentive scheme that offers refund on all hidden and other taxes that were not refunded any other export incentive scheme. This can be central and state taxes on transportation fuel used on export products, duties on electricity used for product manufacturing, toll tax, stamp duties on import-export legal paperwork, etc.

## 3. Transport and Marketing Assistance Scheme (TMA)

The Transport and Marketing Assistance Scheme was launched to promote brand recognition of specified Indian agricultural products across certain export markets. The scheme states that the government will reimburse price inflation costs incurred as freight costs when exporting Indian agricultural goods. Exporters also receive assistance in marketing.

Some of the eligible countries are Australia, New Zealand, Georgia, UAE, Oman, Denmark, France, Brazil, Peru, Egypt, Thailand, Malaysia, Cambodia, South Korea, etc. There are standard rates for sea and air transport. In case of sea transport, standard and reefer's rates apply on each shipment as per the case applicability. LCL cargoes are not included.

Products under Chapters 1 to 24 of the ITC HS Codes are valid for assistance in this scheme.

This scheme is phasing out, hence check the availability of the scheme with DGFT.

## 4. RoSCTL (Rebate on State & Central Taxes and Levies scheme)

The The new export incentive scheme — RoSCTL, introduced in 2019, is applicable on all readymade apparel and textiles like bedsheets, clothing, garments, carpets, rugs, etc. This scheme grants refund on taxes such as VAT on transportation fuel, captive power, 'mandi' tax and electricity duty.

## 5. Duty Drawback Scheme (DBK Scheme)

This scheme is a special rebate under Section 75 of the Indian Customs Act on exported products or materials. It allows exporters to get concessions or compensation on applicable products used in the processing of goods that are manufactured in India and then exported to foreign countries.



## 6. Duty Free Import Authorisation (DFIA Scheme)

The purpose of the Duty Free Import Authorization (DFIA) scheme is to allow the duty-free imports of raw materials. This export incentive scheme enables duty-free imports of fuel, oil, inputs, energy resources, and the catalyst consumed/ utilized in the process of production of export products. Imports under this scheme shall be exempted only from the payment of Basic Customs Duty (BCD).

#### Other Incentive Schemes

#### 1. NIRVIK Scheme


Providing high insurance cover, reduced premium for small exporters and a simplified claim settlement process, the NIRVIK scheme was introduced by the ECGC (Export Credit Guarantee Corporation of India). It is primarily an insurance cover guarantee scheme that provides a cover of up to 90% of the principal and interest, as against the current credit guarantee of only up to 60% loss.

## 2. EOU Scheme (Export Oriented Units)

The EOU scheme was introduced in 1980 with the aim to encourage exports by creating additional production capacity, earn foreign exchange to the country and to generatinge additional employment. 2 It provides a few waivers and concessions in compliance and taxes to the exporters. The companies that are set to export their 100% production of goods are allowed to set up an Export Oriented Unit (EOU).

## 3. Market Access Initiative (MAI) Scheme

The MAI scheme provides financial assistance in export promotion activities to export promotion organizations, trade promotion organizations, national-level institutions, research institutions, exporters, laboratories, etc.



## **Product - Guar Gum**

India is native of guar or cluster bean where it is used as a vegetable. From hundreds of years Guar has been used as vegetable in India. It is also used as cattle food, and as a green manure crop in agriculture. Guar gum comes from the endosperm of the seed of the legume plant Cyamopsis tetragonoloba; an annual plant, grown in dry regions of India as a food crop for animals.

In the early 1900s it was introduced to United States by India. In U.S., most of crop is grown for a lower grade of guar gum which is extensively used in the production of many industries.

Guar gum is a white to creamy coloured, free flowing powder and free from extraneous matter. Its ability to suspend solids, bind water by hydrogen bonding, control the viscosity of aqueous solutions, form strong tough films have accounted for its rapid growth and uses.





#### **Global Trend**


The guar gum market size was valued at USD 1.17 billion in 2022 and is projected to grow from USD 1.25 billion in 2023 to USD 2.01 billion by 2030, exhibiting a CAGR of 7.05% during 2023-2030.

North America dominated the Guar Gum Market with a market share of 50.46% in 2022.








# State of India - West Bengal - W.B.




